## HEADWATER EXPLORATION INC. RESERVES COMMITTEE CHAIR POSITION DESCRIPTION

The following sets forth the position description of the chairperson (the "**Chair**") of the Reserves Committee (the "**Committee**") of the Board of Directors (the "**Board**") of Headwater Exploration Inc. (the "**Corporation**"):

- 1. **Appointment:** The Chair will be a duly elected or appointed member of the Board and be appointed as the Chair by the Board annually; provided that if the Board does not appoint the Chair in any given year the incumbent Chair will continue to serve as long as such person continues to be a member of the Board. The Chair will be independent under the standards for reserves committee independence adopted by the Board and applicable law. The Chair will have the competencies and skills as determined to be necessary and desirable by the Board.
- 2. General Responsibilities: The Chair's primary role is managing the affairs of the Committee, including ensuring the Committee is organized properly, functions effectively and meets its obligations and responsibilities, including those matters set forth in the mandate of the Committee. The Chair will ensure the Committee has effective communication and access to management and staff involved in evaluation of the Corporation's reserves and resources (the "Reserves Evaluation Team"). The Chair shall also ensure that the Committee maintains ongoing and effective communication with the independent qualified reserves evaluator(s) and/or auditor(s) ("Independent Evaluator") of the Corporation.
- 3. **Specific Duties and Responsibilities:** The Chair shall, in addition to any other duties and responsibilities specifically delegated to the Chair by the Committee or the Board, will have the following specific duties and responsibilities for:

## Working with Management and the Independent Evaluator

- (a) lead the Committee in overseeing the work of the Reserves Evaluation Team and the Independent Evaluator;
- (b) lead the Committee in overseeing the integrity of the Corporation's reserves and resources evaluation and reporting process, including the Corporation's internal reserves and resources data preparation controls and procedures, the preparation of the report prepared by the Independent Evaluator in respect of the Corporation's reserves and resources data, and compliance with related legal and regulatory requirements, including National Instrument 51-101 *Standard of Disclosure for Oil and Gas Activities*; and

## Managing the Committee

- (d) chair Committee meetings;
- (e) establish the frequency of Committee meetings and review such frequency from time to time, as considered appropriate;
- (f) ensure that the Committee meets in separate, regularly scheduled, non-management, closed sessions with internal personnel or outside advisors, as needed or appropriate;

- (g) ensure that the Committee is fulfilling its duties as set out in the Mandate of the Committee and pursuant to applicable laws and ensure that the Committee members are aware of such duties;
- (h) assist the Board in its recommendation of Committee members and its review of the performance and suitability of the Committee members;
- (i) ensure the co-ordination of the agenda, information packages and related events for Committee meetings in conjunction with the Board Executive Chair, the President and Chief Executive Officer, Chief Operating Officer and/or other members of the Reserves Evaluation Team;
- (j) endeavour to ensure sufficient time during Committee meetings to fully discuss agenda items;
- (k) maintain a liaison and communication with Committee members, other directors and the Board Executive Chair to coordinate input from Committee members and directors, and optimize the effectiveness of the Committee;
- (1) in collaboration with the Board Executive Chair, President and Chief Executive Officer, Chief Operating Officer and/or other members of the Reserves Evaluation Team, ensure information requested by Committee members is provided and meets their needs;
- (m) in conjunction with the Corporate Governance and Compensation Committee, review and assess Committee attendance, performance and compensation, skills and experience, and the size and composition of the Committee; and
- (n) report to the Board after each Committee meeting at the Board's next meeting.
